3. Legal basis and intended purpose

Video and entrance surveillance is conducted based on a legitimate interest in vandalism protection, ensuring adherence to house rules, as an authorized economic operator (AEO) and as proof of attendance and performance.

4. Groups of data subjects and data or data categories

Essentially, the data or data categories listed below are collected, processed and used with respect to the following groups to meet the purposes listed under item 3:

- Plant entrance: video surveillance, access control data
- Authorized economic operator (AEO): name, address data, birth date
- Calendar management data, plausibility check of service providers' settlement and performance data

5. Data recipients or categories of recipients

- Public bodies that receive data on the basis of legal requirements (such as public prosecutor)
- Internal offices involved in executing the relevant business processes (essentially: HR Management, General Administration, Procurement, EDP, employee representatives).
- Third-party contractors (service providers)

6. Data transfer to third countries

No data is transferred to third countries

7. Standard deadlines for deletion of data

Legislators have issued a range of data storage obligations and deadlines. Upon expiration of these deadlines, the relevant data are regularly deleted provided they are no longer needed for the fulfillment of the contract. If data are not affected by this need, they are deleted if purposes listed under 3. no longer apply.

8. Rights of the data subjects

Data subjects are entitled to:

- Information about which of their personal data are being stored and processed
- Rectification of the personal data stored
- Erasure of data no longer required
- Restriction of the use of data
- Objection (especially where consent was previously granted)
- Data portability
